Membership

There are 2 membership categories available for selection:

- **Full membership** - this is the default option and allows full membership benefits.
- **Associate membership** - allows limited membership benefits for those members who do not qualify for full membership.

Note: Membership must not be confused with merely registering a profile on www.musicinafrica.net. This is membership for individuals or businesses that want to have a say in the direction and governance of the Music In Africa Foundation and benefit from the specialised benefits provided.

4) Governance	<ul style="list-style-type: none"> • You are eligible to attend the MIAF AGM in a different African country every year. • You are eligible to vote at the AGM. • You are eligible to apply for funds to attend the AGM.
5) Information	<ul style="list-style-type: none"> • You are eligible to receive exclusive content and updates for members.

Terms and conditions

- Member benefits are not transferable.
- We reserve the right to reject any member advert if we believe that such advert violates any laws, codes of practice and any sense of decorum.
- The following benefits do not apply to associate members: (1) Voting at the AGM.

Eligibility criteria

- An applicant may be an individual or an organisation.
- All applicants for full membership must be active and able to show proof of their involvement in the field of African music / African music industry. Members who do not meet full membership requirements can be associate members.
- Individual member applicants must be 21 years of age or older.

MIAF reserves the right to seek whatever information is necessary to determine the applicant's eligibility.
