RULES AND REGULATIONS

**This document may be modified at any time without notice. Please contact the event organizers and/or their legal representatives for the latest version of this document. Participation and enrollment in the CHAINSAW Game and Music Festival, requires full acceptance of all clauses and regulations contained in this document. Be sure to read the rules and terms of this document with utmost care before submitting your work or any information. By submitting your information and work you declare you agree to the terms and rules set forth herein.**

## **I -General Terms**

### **Article 1:**

1. All works must be produced and presented entirely by adults (herein considered to be individuals over 18 years of age).
2. Each director, producer group, or company may enter for each work, a separate registration form must be completed.
3. Entries must be formalized by their respective producers and/or legal representatives. The work will only be considered enrolled after completing all the mandatory fields of the registration form and all the requirements met.
4. Works posted after the stipulated registration date will not be accepted.
5. Works that are illegal, offensive, pornographic, contain content that propagates violence, discrimination, and/or violate any national or international law will not be accepted.
6. The CHAINSAW Game and Music Festival will take place digitally/online on the listed page of the event by the organizers to give everyone the chance to participate even if they cannot travel to attend the event in person. In the future, the CHAINSAW Game and Music Festival may be hosted in Brazilian and international cities, and the period and activities will take place in facilities to be defined by the the organization and/or the event organizers.
7. The party submitting any work to the CHAINSAW Game and Music Festival agrees to participate and authorizes the display of the cinematographic work on the CHAINSAW Game and Music Festival, its website and on platforms or video streaming pages such as VIMEO or other video pages.
8. It is herein defined as responsible parties or participants as any person or entity directly or indirectly involved in the completion, submission, filing, or presentation of the film, music, and/or game/work.

### **Paragraph 1:**

The CHAINSAW Game and Music Festival is an event of national and international scope (including international participants that may sign up for the CHAINSAW Game and Music Festival) with presentations of cinematographic works. In summary, the winning exhibition of works performed and selection by the organizers and the organization the CHAINSAW Game and Music Festival encompasses the works of all professionals.

### **Paragraph 2:**

The CHAINSAW Game and Music Festival may be presented in the competitive categories described below:

1. Games of all genres
2. Music of all genres
3. Music Videos
4. Film Soundtracks

### **Article 2:**

The organization and organizers of the CHAINSAW Game and Music Festival have the exclusive right and may establish contacts and/or contracts, and/or association with other public and/or private entities of any size or nature, that may collaborate and/or participate in the CHAINSAW Game and Music Festival.

### **Article 3:**

The organization and organizers of the CHAINSAW Game and Music Festival's focus is to present recent productions/works, seeking to contribute to its diffusion and/or discussion with the intent to bring together artists and game developers, promoting the innovation of digital exhibition of artistic creations, in order to create an opportunity for individuals who cannot physically be present and participate in person in the CHAINSAW Game and Music Festival.

## **II - The Films and/or Games**

### **Article 4:**

Only feature films, short films, and games that were completed thirty-six (60) months prior to the CHAINSAW Game and Music Festival submission deadline can participate in the CHAINSAW Game and Music Festival.

### **Article 5:**

1. In online Festival and festivals in physical locations, once requested by the organization and/or organizers of CHAINSAW Game and Music Festival, all artists agree to participate in the festival in person by sending up to three representatives of the winning film and up to three members of the film, music, and/or game-making team.
2. In digital presentations, it is established and accepted by the registrants and winners (Brazilian and international) selected for the exhibition of the CHAINSAW Game and Music Festival, that they will ensure the presence of at least one representative of the winning film and up to three members of the team that may be broadcast through video and transmitted online.
3. It is established and accepted by the registrants and those selected to participate that they will not receive nor be entitled to any remuneration of any kind, including airfare, transportation, health and dental care, lodging, and/or any other expenses, costs, or any type of monetary aid, insurance, or any other type of expenses, legal assistance, emergency assistance, fees, legal or physical indemnification, refunds, or any kind of monetary aid, paid its organizers and any other members and/or representatives directly or indirectly affiliated with the CHAINSAW Game and Music Festival.

### **Paragraph 1:**

1. Individuals representing the winning film may be invited to participate in the CHAINSAW Game and Music Festival by its organizers, at the sole discretion of the organizers and the organization of the the CHAINSAW Game and Music Festival.
2. However, it is stipulated that persons invited and accepting to participate in the CHAINSAW Game and Music Festival, that they declare that they accept that they will not have the right to claim in any form or event, any monetary amount and/or compensation to be paid by the organizers and the organization of the CHAINSAW Game and Music Festival and its representatives, in association or connection and not limited to to airfare, transfers, translators, lodging, travel expenses, acts of nature, acts of war, acts of violence of any nature, natural Disasters, riots, terrorism, strikes, cyber attacks, accidents, medical expenses, hospital, dental, death, damages of any kind, losses of any kind, acts of God, natural disasters, medical or other form of emergency evacuation, riots, damages of any nature, defamation of any nature, illegal or illegal acts of any nature, legal fees and legal expenses associated with governmental bodies or with private entities or with individuals of any nature, and/or any other expenses, costs, translators, and/or any monetary assistance and /or insurance which may be incurred or in association with other events, incidents, or actions.

### **Paragraph 2 :**

The organizers of the CHAINSAW Game and Music Festival may invite critics, authorities and/or other persons related to the cinema, literature, and/or other professional fields, as well as sponsors and/or other private and/or governmental entities.

## **III – Registration**

### **Article 6:**

Registration and delivery of copies of works in the categories of feature films, short films and games, that will compete for the competitive selection of the CHAINSAW Game and Music Festival must be completed as follows:

1. The registration documents must be completed and sent before the deadline indicated on the page of the organizers of the event and/or the website or registration platform, and/or to the email indicated by the organization and/or organizers of the event.
2. Copies for selection shall be posted or delivered to the CHAINSAW Game and Music Festival organizers through the CHAINSAW Game and Music Festival site, platform, and/or or e-mail along with the material requested in this document and the per the directions of the organization and/or organizers of the event.
3. It will also be acceptable to send the material for evaluation and competitive selection through a private link for viewing with a password and available for download until the deadline stipulated by the organization and/ organizers of the event.

**Paragraph 1:**

Failure to comply with the rules set forth in this document will result in disqualification of the participants without any form of appeal.

It is the sole responsibility of the film, music, and/or game owner to participate in the the CHAINSAW Game and Music Festival and to comply with the rules stipulated by the organizers of the event as described below:

1. Sending all of the correct and necessary materials for registration, selection and (if chosen) participation.
2. Meeting all of the deadlines for registration, selection and participation (if chosen) to send materials obeying the rules stipulated by the organizers of the event.
3. Each registered work must be sent via private link for viewing with a password and should be available immediately for download.
4. The registration and submission of all short film, feature film, audio narrative poetry films, and any other category defined by the organization and the organizers of the CHAINSAW Game and Music Festival should also be sent with a dialogue list, a narrated version that can be accessible for visually impaired individuals (a version in English), a subtitled version for hearing impaired individuals (a version in English).

**Paragraph 2:**

The organization and organizers of the CHAINSAW Game and Music Festival are not responsible for problems associated with the transmission or receipt of materials and/or works through private link for viewing with password, problems contained in the website or the link, general access problems, incorrect passwords, problems in the security of the website, cyber attacks, viruses, or any other types of errors, technical problems or any actions or events of any nature that may occur.

**Article 7:**

At the time of submission of a work to the CHAINSAW Game and Music Festival in any category, the party submitting the work shall:

1. Complete the document, through the website or through another method that is stipulated by the organizers and the organization of the CHAINSAW Game and Music Festival;
2. Send in addition to the completed submission of the work, three photos (JPEG files) with a minimum resolution of 300 DPI, with 18 x 24 cm dimensions, with a maximum of 2000kb and with an indicative description and photographs of the artists, directors and technical crews.
3. Have the legal and copyright rights to the submitted work.
4. Provide the organization and organizers of the CHAINSAW Game and Music Festival worldwide unlimited royalty free license to present, distribute and use in any form, waiving any type of fees, royalties, or any kind of compensation or demand of right of any nature. You agree that you waive and relinquish any legal rights any fees, royalties, or any type of compensation or legal and/or financial demand and/or litigation of any kind whatsoever in connection to the organization and organizers of the CHAINSAW Game and Music Festival.
5. Have full releases for all performers associated with and performing on film, providing signed and legally valid permissions of all individuals associated with the film, music, and/or game and individuals acting on the film, music, and/or game. You must present legally valid documentation of all persons involved in the film, music, and/or game, including actors, with their full authorization to submit their performance and likeness in association with the registration, selection and exhibition of the work. You must also submit documentation that you have their legal permission to have their work presented at the festival, waiving any legal claim that may be filed at any time against the organization and organizers of the CHAINSAW Game and Music Festival and other directly or indirectly associated and / or affiliated parties.

**Paragraph 1:**

The registration platform or other registration method provided to submit works to the CHAINSAW Game and Music Festival may send a message about the registration of the film, music, and/or game by electronic mail confirming your registration. If you do not receive the message after three business days from the date of registration, please contact the registration platform and the organizers of the CHAINSAW Game and Music Festival immediately.

**Paragraph 2:**

When registering and submitting works to the CHAINSAW Game and Music Festival the person responsible for registration and all those involved in the creation of the inscribed film, agree, authorize and give full rights to the organizers and the organization of the the CHAINSAW Game and Music Festival to disclose the names of the works and/or films, the authors of the film, music, and/or games and/or of all participants that who worked in the film, music, and/or game, and any other personal identification information without incurring in any form of fee collection, royalties, litigation, and/or any other kind of compensation, or demand of legal right of any nature to the organizers and the organization of the CHAINSAW Game and Music Festival, their representatives, associates, affiliates or any other parties directly or indirectly associated with the CHAINSAW Game and Music Festival.

#### **IV - Selected Works**

All selected feature films, short films, and games for competitive shows, must, at the discretion of the organizers, send the copies for display until the date indicated by the organization and organizers of the CHAINSAW Game and Music Festival including digital posters of the film, music, and/or game. It is stipulated and accepted by the registrants that failure to comply with this rule will automatically disqualify the selected films.

**Paragraph 3:**  
It is stipulated and accepted by the registrants that promotional materials for the film, music, and/or games, that films and any other materials will not be returned and will remain in the possession of the organization and the organizers of the CHAINSAW Game and Music Festival.

#### **V - Copies of the Works**

Copies of all films and games that will participate in the CHAINSAW Game and Music Festival must meet the following criteria:

1. For Online events a copy will be submitted in digital MOV-H264 file via Vimeo link or other requested platform.
2. For physical events a copy will be submitted in (digital MOV-H264, DCP unlocked, or Blu-Ray) . Digital films will be displayed on a 2K or 4K resolution projector.
3. For Games a working copy of the game must be provided (Either via Direct download or game key). Games must only be provided in Windows PC or Android Mobile compatible formats.
4. For selected Games, a trailer of the game must be available via Vimeo link.

#### **Article 8:**

It is stipulated and accepted by the registrants that the copies of the selected films, works, and/or any other materials will not be returned under any circumstances.

#### **Article 9:**

Directors and producers of feature films may choose to send copies with sound set to 2.0 (STEREO).

#### **VI - Rules for the submission of films/works, documents and materials**

##### **Article 10:**

Copies of films/works submitted for selection should be sent via private link for viewing with password and available for download in addition, to copies of the film, music, and/or games/works for presentation, and the required materials should be sent via the method indicated by the organization and organizers CHAINSAW Game and Music Festival.

##### **Article 11:**

The organization and organizers of the CHAINSAW Game and Music Festival will not collect any material, film or document sent to any post office or other location or method in any form, including C.O.D., for payment, or refund of postage, as well as will not make any refund or indemnity any parties on postage, undelivered mail, or damages to materials.

#### **VII - Selection Process**

##### **Article 12:**

Short films, feature films and narrative audio video poetry, and any other category defined by the organization and the organizers of the CHAINSAW Game and Music Festival will be selected for competition and final participation in the film, music, and/or game shown by the organizers and the organization of the CHAINSAW Game and Music Festival at the sole discretion of the organization and the organizers of the CHAINSAW Game and Music Festival.

##### **Paragraph 1:**

The CHAINSAW Game and Music Festival may or may not charge for event tickets or products, and this decision is at the sole discretion of the organization and the organizers of the CHAINSAW Game and Music Festival. Financial resources, profits, and monetary amounts from the sale of tickets, products, or any activity will be the exclusive property of the organizers and the organization of the CHAINSAW Game and Music Festival. Registrants, individuals or entities or any other party other than the organization and the organizers of the CHAINSAW Game and Music Festival waives the right to any portion of financial resources, profits, and monetary amounts from the sale of tickets, the CHAINSAW Game and Music Festival or any

associated activity, product, or event.

## **VIII - Competition**

### **Article 13:**

The CHAINSAW Game and Music Festival includes films and games from everywhere.

Films and/or games:

1. Films and games will be accepted in the competition. These films will be selected by the organizers of the CHAINSAW Game and Music Festival among works that have not been commercialized in anywhere. The organizers of the CHAINSAW Game and Music Festival may invite other non-registered films and games to participate in the competition, at their sole discretion and at any time. It is mandatory that all films have a self descriptive and narrative caption for individuals with visual and hearing impairments (in English) or the film, music, and/or game cannot participate in the CHAINSAW Game and Music Festival, and would be disqualified. The selected film must be subtitled in English.
2. Films will be considered films/works that are produced anywhere.
3. Those responsible for films and/or games enrolled in the CHAINSAW Game and Music Festival, must send via private link for viewing with password, and available for download, so that the film, music, and/or game can be evaluated by the organizers of the CHAINSAW Game and Music Festival. The film, music, and/or game must be accompanied by the list of dialogues, and subsequent translation and subtitles in English of the effectively selected works must to be sent by the registrants directly to the organizers of the CHAINSAW Game and Music Festival via email and via private link for viewing with password, and available for download, within one (1) week after being notified or they will be disqualified.

### **Paragraph 1:**

Winning films, games, works, and/or trailers may be displayed on the CHAINSAW Game and Music Festival website and/or external video page as VIMEO STREAMING. As well, it is up to the organizers of the CHAINSAW Game and Music Festival to potentially choose in the future a physical location for the exhibition of the film, music, and/or game. The number of films/games to be selected and displayed is decided at the sole discretion of the organization and organizers of the the CHAINSAW Game and Music Festival.

### **Paragraph 2:**

It is stipulated and accepted by the registrants, their representatives, families, and all involved directly or indirectly with the submitted films/games/ and/or materials that there will be no remuneration, no financial compensation of any kind or nature, no royalties, and no form of financial or any other form of compensation now or in the future. In addition, registrants, their representatives, families, and all involved directly or indirectly with the submitted films/games/ and/or materials waive any rights to be compensated financially in any civil, criminal, and/or legal proceeding against the organization and/or organizers of the CHAINSAW Game and Music Festival and their representatives and/or associated parties. Those responsible for the winning films/games will only receive an electronic certificate via e-mail as participants and/or winners of the CHAINSAW Game and Music Festival.

### **Paragraph 3:**

If there are taxes and/or taxation associated with the works/films/games, these amounts will be paid exclusively by those submitting the works/films/games in the Festival.

### **Paragraph 4:**

#### **Selection of competing short films:**

Works will be selected for the short films competition of films produced by companies and/or individuals, completed 60 (sixty) months before the registration deadline of the CHAINSAW Game and Music Festival and lasting up to 30 minutes, including credits.

### **Paragraph 5:**

#### **Selection of feature-length films:**

Works will be selected for the short films competition of films produced by companies and/or individuals, completed 60 (sixty) months before the registration deadline of the CHAINSAW Game and Music Festival and lasting up to 150 minutes, including credits.

## **Paragraph 6:**

### **Selection of Games:**

Works will be selected for the games competition of games developed by companies and/or individuals, completed 60 (sixty) months before the registration deadline of the CHAINSAW Game and Music Festival. Games must only be provided in Windows PC or Android Mobile compatible formats.

## **IX- Awards**

### **Article 14:**

1. The organization and/or organizers of the CHAINSAW Game and Music Festival will choose the winners according to the completion of the registration forms of the film, music, and/or game. Their decisions are irrevocable and cannot be appealed.
2. The organization and/or organizers of the CHAINSAW Game and Music Festival will not be responsible for the winners' certificates of the CHAINSAW Game and Music Festival after being handed over to the winners, and shall not be liable for loss, transmission errors or technical failures, acts of nature, malicious actions of third parties and any kind of civil or criminal acts of any nature.

### **Article 15:**

The organization and/or organizers of the CHAINSAW Game and Music Festival have the right at their sole discretion to change the registration deadlines, rules and/or regulations, the format of the event, to change the number of works/films/games, and to disqualify or to withdraw any work/film for any reason.

### **Article 16:**

The decisions of the organization and/or organizers of the CHAINSAW Game and Music Festival are irrevocable and not subject to appeals.

### **Article 17:**

The organization and organizers of the CHAINSAW Game and Music Festival reserves the right to disclose names of the selected films/games to the CHAINSAW Game and Music Festival at their sole discretion.

### **Article 18 :**

No film, music, and/or game selected to the CHAINSAW Game and Music Festival may be withdrawn from the CHAINSAW Game and Music Festival unless the organization and/or organizers of the CHAINSAW Game and Music Festival so determine and communicate in writing to the participant that they accept the withdrawal of the film, music, and/or game.

## **X - Participation Terms**

1. Participation in the CHAINSAW Game and Music Festival implies acceptance of the following:
  - a) The organization and organizers of the CHAINSAW Game and Music Festival, their associates, representatives and affiliates are not directly or indirectly responsible for matters relating to copyright and other intellectual property rights to any portion of submitted contents and materials of the submitted works.
  - b) Individuals and entities submitting their works to the CHAINSAW Game and Music Festival hereby agree to be legally and financially responsible for any and all civil, legal and criminal liability related to all materials, information works, and films submitted to the CHAINSAW Game and Music Festival.
  - c) participants retain all ownership rights and copyright of their own original works. Participants agree to provide to the organization and organizers of the CHAINSAW Game and Music Festival an irrevocable, transferable, worldwide license to total and partial transmission of the material sent for distribution, copy, and any type of use, including but not limited to public and/or paid television, cinema, internet or any other existing means of communication and media that may exist, without limit of use or quantity of reproductions, waiving the participants' rights to financial or other form of compensation.
  - d) Individuals and entities submitting their works to the CHAINSAW Game and Music Festival hereby hold harmless, indemnify, and protect in legal proceedings (including court costs and attorneys fees) the organization and organizers of the CHAINSAW Game and Music Festival their associates, representatives and affiliates for any and all civil, legal and criminal liability related to all materials, information works, games, and films submitted to the CHAINSAW Game and Music Festival and any other associated action or incident.

Participants automatically assign to CHAINSAW Game and Music Festival the rights of total or partial transmission of the material sent for distribution and for any type of use, including in public and /or commercial television, cinema, internet or any other means of communication existing and/or that will exist, without limit of use or quantity of reproductions.

Individuals and entities submitting their work to CHAINSAW Game and Music Festival hereby declare that they exempt, indemnify and hold harmless from litigation (including any kind of legal costs and expenses, attorney's fees and/or any kind of expenses and costs) the organization and organizers of CHAINSAW Game and Music Festival , its associates, representatives and/or any person and / or associated entity of all Any civil, legal, legal and penal liabilities related to all materials, information works, games and films submitted to the CHAINSAW Game and Music Festival. In addition participants hereby also indemnify, release, and hold harmless the organization and the organizers of the CHAINSAW Game and Music Festival from any responsibility related to other actions and / or incidents that may exist in the present and/or in the future.

e) Participants automatically authorize the reproduction and use, in whole or in part, of their works in the collection of those selected for the CHAINSAW Game and Music Festival. Participants automatically authorize the use of the author's likeness, image, and voice in all media and/or printed materials, for an indefinite period, waiving any rights to compensation and legal claims in connection thereof, without any restrictions in connection with promoting the CHAINSAW Festival and its organizers and organization in any other venue or instance.

f) The organization and organizers of the CHAINSAW Game and Music Festival is not responsible for possible loss, damage, loss or loss of materials.

g) The expenses of transportation, taxes, and costs associated with any materials/games/and or films shall be the sole responsibility by participants and their legal representatives.

## **XI - Information regarding selected films and games**

Works/films that are selected must be submitted along with following information via e-mail:

1. Cast, synopsis and technical information (maximum of 500 characters).
2. Trailer or official teaser of the film, music, and/or game (via vimeo and/or other requested platforms).
3. Minimum 3 photos of the work/film in high resolution.
4. Maximum of 5 photos of the director(s) (resolution of 300 dpi, 10x15cm).
5. Maximum of 5 stills of the work/film (300 dpi resolution, 24x15cm).
6. Biography and complete filmography or developer experience of the director(s)/developer(s).
7. Original and English dialogue lists and list of subtitles in English formatted to meet the needs of individuals with visual and hearing disabilities.
8. Credits.
9. Contact information.
10. Production, co-production, and distributing company information (including contacts).
11. Film trailer if applicable via VIMEO link.
12. Game key or Direct Download link to game in Windows PC or Android Mobile formats.

### **Article 19:**

The issues associated with this document's rules and regulations will be addressed at the sole discretion of the organization and/or organizers of the CHAINSAW Game and Music Festival.

### **Article 20:**

1. If any term of this document is not fulfilled by the responsible parties, their legal representatives, and/or associates, or any individual, company or entity related to the work presented at the time of submission and after the submission of the work/film, music, and/or games, the registration of the film will be automatically invalidated.
2. All information entered on the form and the documents provided must be true. If there is any information that is not in agreement with what is stated, at the time of registration or afterwards, the organizers and the organization of the CHAINSAW Game and Music Festival have right to cancel the registration, withdraw the work/film, music, and/or game, and/or void any prize without notification.

### **Article 21:**

Those responsible for submitting their films, their games, their legal representatives, associates, and any party directly or indirectly associated to them or the submitted work and/or film/and or game, waive any liens, financial and any legal rights against the organization and organizers of the CHAINSAW Game and Music Festival, their relatives, legal representatives, associates or any other party directly or indirectly linked to the CHAINSAW Game and Music Festival.



**Article 22:**

1. Participation in the CHAINSAW Game and Music Festival represents full acceptance and full compliance with all terms and conditions set forth in this document's terms, rules, and regulations.
2. Works/films/games must comply with the technical specifications indicated by the organization and organizers of the CHAINSAW Game and Music Festival.
3. The CHAINSAW Game and Music Festival reserves the right to cancel the participation of any selected film, music, and/or games that does not submit copies within the technical standard established by the organizers of the CHAINSAW Game and Music Festival and does not comply this document's terms, rules, and regulations.

**Article 23:**

1. The CHAINSAW Game and Music Festival , its officers, associates, affiliates, family members, legal representatives, or any party directly or indirectly involved with the CHAINSAW Game and Music Festival are not responsible nor liable in any instance for materials and contents included in the inscribed film, music, and/or games that may involve illegal actions related to copyright, unauthorized materials and content included as part of the film, games or any material and content considered to be unlawful in any civil, criminal, private or governmental instance.
2. It is the sole responsibility of the applicant to ensure the proper permission of the copyright owner for full or partial use of any part of the project, music or any other material and content thereof, including ensuring that there is authorization from all parties involved on the film, music, and/or game allowing the unrestricted and unlimited use of the materials and contents in order that they may protect the copyrights of entities or individuals related to the production and execution of the film, music, and/or game. In addition, it is stipulated that the legal representatives of the film, music, and/or game submitted are solely responsible for any kind of error, omission, negligence, moral damages, financial losses, safety, death, accidents, violence, perjury, defamation, any kind of action that may result in damages and damages not mentioned in this document, any legal problems related to the civil and criminal area. as well as, the applicant is solely responsible for any copyright infringement of the material and content that is provided with permission to post your images, posters and trailers on the site and / or social media pages and / or other media.
3. The presentation of the film, music, and/or game in the the CHAINSAW Game and Music Festival shows that the registrants fully agree and accept all the policies set out in the application form and also agree and fully accept the stipulated rules of the submission guidelines.
4. In the event of unexpected circumstances, it is established that the organization and organizers of the CHAINSAW Game and Music Festival have full and exclusive powers to change the places of registration, presentation, date, or cancellation of the event without prior communication or permission of the participants.
5. It is determined that through this document, I(we) agree to allow my (our) film, my (our) game to be displayed on the CHAINSAW Game and Music Festival or other locations and media selected by the organizers and the the CHAINSAW Game and Music Festival organization.
6. 6. I(we) declare that I (we) are the sole owner (s) of all copyrights and legal title (s) and have the legal authority to send the materials and contents attached to the the CHAINSAW Game and Music Festival. In addition, I (we) accept and declare that any legal problems are in the civil, judicial and criminal areas arising from false declaration, omission and / or errors, are exclusively my responsibility and completely exempt the organizers And the organization of the CHAINSAW Game and Music Festival to respond legally for any legal, judicial and criminal infractions that may be committed by me (us) nationally or internationally.
20. I (we) also accept (without limitation) that on behalf of each of the registrants, owners, creators and members and entities associated with the inscribed film, that the organizers and the organization of the CHAINSAW Game and Music Festival have the power Exclusive and absolute jurisdiction to decide and determine the scope or applicability of the arbitration agreement, which shall be governed by the internal rules of the organization of the CHAINSAW Game and Music Festival , and shall be subject, if it is so decided, to the submission of exclusive arbitration, attaching this fact to a single arbitrator And with the exclusion of the forum for determination of such claim, dispute or controversy that may arise between the parties representing the inscribed film and the organizers and the organization of the CHAINSAW Game and Music Festival. Any arbitration will be administered under the legal terms that regulate the simplified rules of arbitration and with procedures in force. The arbitrator will be selected by the organizers and organization of the CHAINSAW Game and Music Festival , with their costs paid and that will be the total responsibility of the owners, creators and members and entities associated with the inscribed film. The arbitrator shall issue a writing award and shall have the right monetary relief prize which shall not exceed the amount above the cost of submitting a film or work to the CHAINSAW Game and Music Festival.

The arbitrator shall not have the power of award, and shall be solely responsible for the arbitration award, legal fees, costs and expenses incurred in connection with the arbitration (including, without limitation, reimbursement of that portion of arbitrator's fees and administrative The costs incurred and that will be the total and exclusive responsibility of the owners, creators, and members and entities associated with the inscribed film shall be final, binding and cannot be appealed. The organizers and the organization of the the CHAINSAW Game and Music Festival have absolute power to decide whether they will be brought to civil, judicial and criminal dispute and instead of a dispute settled through arbitration, any kind of claim, any other form of complaint Or cause of action of any nature whatsoever Arising from actual or alleged non-performance, termination, application, interpretation or validity of the Terms and Conditions governed by this document.
22. I (we) also accept (without limitation) that on behalf of each of the owners, creators and members and entities associated with the inscribed film, that the organizers and the organization of the CHAINSAW Game and Music Festival have the exclusive and absolute power To decide and determine the scope or applicability of the convention of any legal action against the creators and members and / or associated entity in national or international court or forum to be selected at the discretion of the organizers and the organization of the CHAINSAW Game and Music Festival , which shall be governed by the internal rules Of the organization of the CHAINSAW Game and Music Festival, and will be subject, if it is decided, the submission of exclusive legal process, linking this fact before a forum determined by the organizers and the organization of the CHAINSAW Game and Music Festival to determine such claim, dispute or controversy that may arise between the parties representing the rights of the submitted works and the organizers and organization of the CHAINSAW Game and Music Festival. The national and/or international forum or court will be selected by the organization and/or organizers of the CHAINSAW Game and Music Festival.
23. Parties submitting works, owners, creators and members and entities associated with the submitted film shall be liable solely for the costs of the proceedings, and any costs and expenses that may be imposed on the organizers and the organization of the CHAINSAW Game and Music Festival , including but not limited to attorneys' fees, costs And expenses incurred in connection with any proceeding of any legal nature, including, but not limited to, reimbursement of that portion of attorneys' fees and court costs, administrative charges, costs paid, expenses and costs of any nature in any legal, And are the sole and exclusive responsibility of the owners, creators, members and entities associated with the film, music, and/or game. The organizers and organization of the CHAINSAW Game and Music Festival have the absolute power to decide whether any claim and any other claim or cause of action of any kind arising from actual or alleged non-performance, termination, enforcement, interpretation or validity of these Terms and how Complaints and or legal claims and/proceedings may be brought into dispute in civil, criminal, appeal courts and/or arbitration.
24. The owners, creators and members and entities associated with the inscribed film waive any value that may be given to them in any legal proceeding, and to any amount over

and above the total value of a film, music, and/or game's entry in the CHAINSAW Game and Music Festival.

25. By agreeing to this exclusive arbitration provision, I (we) also accept without limitation, on behalf of each of the owners, creators and members and entities associated with the submitted film that I (we) waive any rights that I or each of the owners, creators, and members and entities associated with the submitted film may have obtained through legal proceedings litigated over any type of claim or claims in any federal or state national or international court, against the organizers and organization of the CHAINSAW Game and Music Festival, or any party related to the CHAINSAW Game and Music Festival, and also releases/waives any right to a jury trial in relation to such claims or any other claims.
26. I (we) acknowledge that I (we) have the right to consult an attorney of my own choosing with respect to these Terms and Conditions and with respect to the rules and regulations for submissions, selection and presentation of the film, music, and/or game to the organizers and the organization of the CHAINSAW Game and Music Festival. Upon completing my enrollment for the CHAINSAW Game and Music Festival and for selection consideration, I (we) accept and make this decision after having consulted an attorney or freely and voluntarily opt out of doing so out of our own volition and without coercion of any kind.
27. I (we) declare that I (we) have read and understood the rules and regulations for the filing, selection, and filing of the film, music, and/or game in the CHAINSAW Game and Music Festival, and that the information contained in the aforementioned rules and regulations of this document supersedes any information obtained in other source (written or implied) sites or places, including, but not limited to, information contained in any frequently asked questions (FAQ) documents.
28. I (we) also accept and declare that, without limitation of any form, on behalf of each of the owners, creators and members and entities associated with the submitted film, that upon completing my (our) (I) freely and voluntarily give and express my full and complete acceptance of all terms and provisions contained in these terms and conditions of this document. I acknowledge that there may be oral presentations, forms of marketing, representations, publicity, and other forms of disclosure by the media, and that there are no promises, legal obligations, or warranties of any kind, and there are representations, promises or warranties made by any party and / or entities associated with the CHAINSAW Game and Music Festival or its organizers, provided in the Terms and Conditions herein, which have been made to me or to the owners, creators, and members and entities associated with Film submitted to the organizers and the organization of the CHAINSAW Game and Music Festival.

**Article 28:**

If any part of this document, terms, articles, or regulations is invalidated, the remaining parts will remain in force.

**Article 29:**

I (we) represent that I(we) have been advised by an attorney, that I (we) have read and agree with the terms and conditions contained in this document, that I(we) had ample opportunity to be advised by an attorney, and that I (we) understood and will comply with all rules and regulations stipulated in this document. I (we) acknowledge the significance and consequences of accepting the rules, terms, waivers of rights, and regulations contained in this document. I(we) declare that I(we)am (are) of adult age and of legal and physical sound mind and body to accept this agreement.
