## 06 Gospel Music

"For the purpose of assisting the judges of the Crown Gospel Music Awards, Gospel Music shall include lyrics which have a common theme of praise, worship and giving thanks to God and/ or Christ based on the historically orthodox Christian faith contained in or derived from the Holy Bible; or apparently promoted and informed by a Christian world-view. In the event of any doubt in content the judges' decision is final and binding."

## 07 Who is Eligible to Enter?

- \* The awards are open to all Recording Companies, Artists, Producers, Engineers, Composers and Promoters who are citizens or legal residents of South Africa. The category for best of Africa Gospel is open to all recording companies and artists, from the African continent (outside SA borders)
- \* Only the work(s) that have been released in the past 36 months
- \* The **BEST CLASSIC OF ALL TIME** category entry should be an original South African song which has been released 7 or more years ago counting from the current awards year, and the entrant must have been the Composer and/or Author thereof.
- \* International collaboration and productions are also encouraged to enter, provided that any collaboration is predominantly by South African Artist(s) or Producer(s) and such artist(s) or producer(s) has/have star or equal billing on the release.
- \* After the closing date for entries, a process will be implemented to ensure that all entries are placed in the correct or most appropriate category (in terms of the rules of the awards ceremony below).

## 08 General Rules

1. The judges' decision is final in relation to any award and no correspondence will be entered to in relation to the judges' decision .
2. The WGPH accepts no responsibility whatsoever for any problems resulting from incorrect or incomplete entries
3. The judges shall not be required to provide reasons for any decisions in respect of the competition.
4. The WGPH reserves the right to cancel, modify and amend the competition rules at any time if deemed necessary in its opinion and if circumstances beyond their control arise. A copy of the rules and any amendments will at all times be available on the official website [www.wgph.co.za](http://www.wgph.co.za).
5. By accepting the nomination to Crown Gospel Music Awards, each nominee is deemed to have accepted these rules and the rules contained in the WGPH website in terms of clause 4 above.
6. The judges shall have the right to disallow entry forms in the following instances:
  - (i) The nominator provided insufficient information to verify the entry;
  - (ii) No contact is readily available on the entry form
  - (iii) The work entered does not fall within the Gospel Music genre
  - (iv) The entrant is not eligible to enter;
  - (v) Where there has been non-compliance with the rules in one way or the other
7. The judges and the WGPH shall have the right to:
  - (i) Place any entry into the category it deems appropriate;
  - (ii) Rule on the eligibility of any entry;
  - (iii) Withdraw any category for that particular year if WGPH is of the view that there is an insufficient number of eligible entries in that category that year. In this instance, WGPH may, in its discretion then place any affected entries in another category.
8. By accepting the nomination, the nominee hereby agrees to be bound by the rules and hereby grants to the Crown Gospel Music Awards and WGPH, the rights to do the following:
  - (i) To use each nominee's photographs, name, image, likeness, biography, interviews and recorded performance for marketing, advertising, filming and broadcasting the Crown Gospel Music Awards.
  - (ii) To use nominee's sound recordings in synchronisation with the broadcast of the Crown Gospel Music Awards on television and in promoting, marketing, advertising , filming and broadcasting the Crown Gospel Music Awards. The nominee warrants that he/she is under no disability, restriction of prohibition from granting the rights as aforesaid to the WGPH and indemnifies the WGPH against any claims which may be brought against the WGPH as well as any harm, loss or damage that the WGPH may suffer as a result of the nominee failing to adhere to this warranty.
9. Each entrant and nominee indemnifies the sponsors, WGPH, Crown Gospel Music Awards, its licencees against any liability and against any claims which may arise directly or indirectly from any breach of these rules. This indemnity shall survive the completion of the awards
